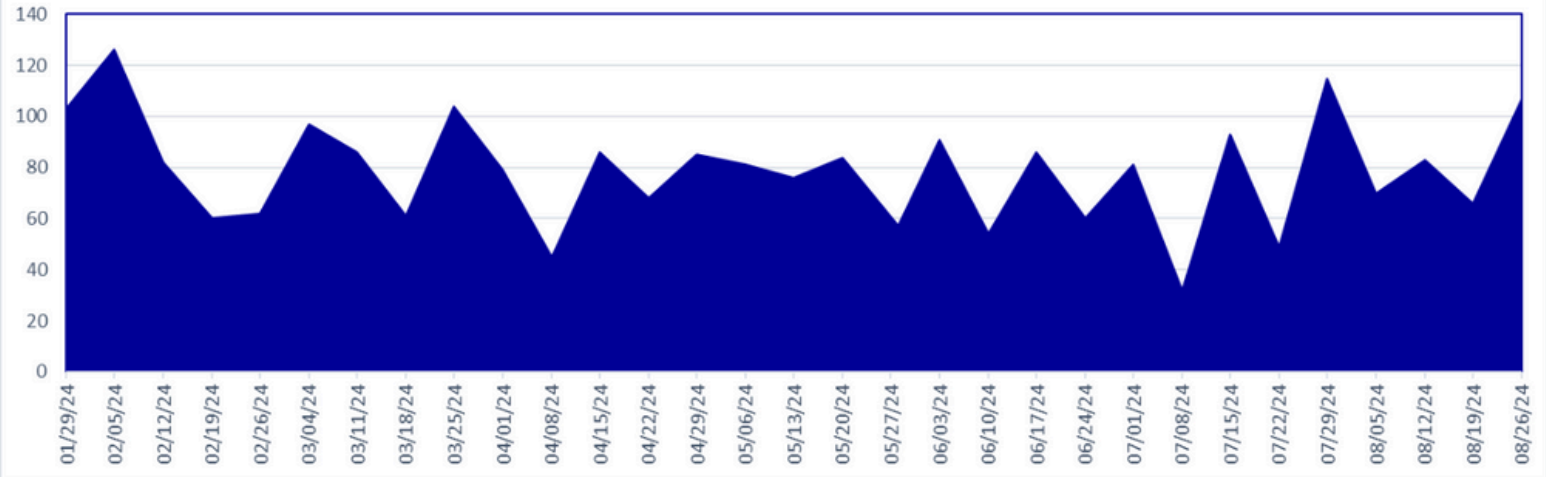

# WEEK-BY-WEEK TRENDS

## Number of NEDs Recorded

Adams, Arapahoe, Boulder, Clear Creek, Douglas, Denver, Elbert, El Paso, Jefferson, Larimer, Pueblo, Weld Counties



### Pre-Foreclosure

#### Default

*Borrower defaults on loan when 30 days late. Borrower is notified by lender of default. This period can last up to 120 days.*

### Foreclosure Begins

#### Notice of Election & Demand

*The lender files a Notice of Election & Demand.*

### Foreclosure Period

#### Residential Foreclosure

*The Public Trustee sets a Sale Date for 110 – 125 days after the NED is filed. Borrower can file an Intent to Cure.*

### Foreclosure Sale

#### Certificate of Purchase

*At the Public Trustee's Foreclosure Sale the highest bidder will receive a certificate of Purchase.*

### Confirmation Deed

#### Finalized Sale

*If no Junior lien holder files an Intent to Redeem, the Public Trustee will execute and record a Confirmation Deed to the holder of the Certificate of Purchase, 10 – 15 days after the Foreclosure Sale.*
